



# Diplômes Supérieurs de l'Université (DSU)

Considered as the top University in the field of law in France, Paris-Panthéon-Assas University created specific Master-level law degrees designed especially for international students. The DSU combine introductory courses in French law, French legal methodology and specialized law courses over one year. French as a foreign language courses also complete the program.

Classes are held in the latin quarter of Paris, in the 6th arrondissement, near the Panthéon and the Jardin du Luxembourg.

The DSU offers a complementary qualification and can also constitute a preparatory year for students aiming to enter a Master's degree in France. Students take fundamental courses in French private and public law, in addition to lessons in the methodology of French legal exercises. In addition, the program includes 3 specialization courses (lectures and tutorials). Finally, to enhance their level of French students will benefit, throughout the academic year, from language courses adapted to their needs.

- Test de connaissance du français (TCF) with written expression
- Test d'évaluation du français (TEF)
- Diplôme d'études en langue française (DELF)
- DU of French as a foreign language from a French university
- Diploma from the Sorbonne French Civilization Course
